# Conditions

The length of the leasing is specified on the contract whether hourly, daily or on weekend basis. Any delay in returning the bicycle/Ape Calessino/Scooter on the agreed time will be charged to the client.

The vehicle is to be returned to the shop it was rented from, otherwise, once the leasing time has expired, the leaseholder is entitled to withdraw the bike.

The client may extend the leasing period, but he/she should inform the leaseholder before the original leasing period has expired. The client must pay the remaining amount once the bike returns in the shop.

The vehicle must return in the same conditions as it was leased. Any damages or missing parts must be paid by the client upon returning the vehicle.

It is not permitted to transfer, to sell or to trade the vehicle or any of their pieces or accessories. If so, the leaseholder might take legal actions, and the client will incur into penalties and fines. Client is not permitted to: A) Driving under influence of alcohol or illegal substances, B) Transporting any other person or child without the appropriate extra seat. C) Clients are not permitted to take the vehicle outside Valencia's metropolitan area.

The client takes full responsibility for the vehicles at all times and must ensure that it is secured when left unattended. IN CASE OF THEFT OR TOTAL SINISTER, A FEE OF (BICICLETA ELÉCTRICA 26" €649, BICICLETA ELÉCTRICA 28" €899 ) MUST BE PAID.

The client is not entitled to a reimbursement if the vehicle is returns before the expiration time of the leasing contract.

The client will provide a (bike €500) deposit, which will be refunded after the shop has verified that the vehicle is returned on the same conditions as it was leased.

Valencia Manía is NOT liable or responsible for injuries, accidents, claims or damages to a third party, which the client may suffered during rental period. The rental does not include any insurance by Valencia Manía.

The applicable laws of Valencia govern this contract.

The charges to the client for damages or theft to Valencia Manía "bikes", while in client's possession are the following:
